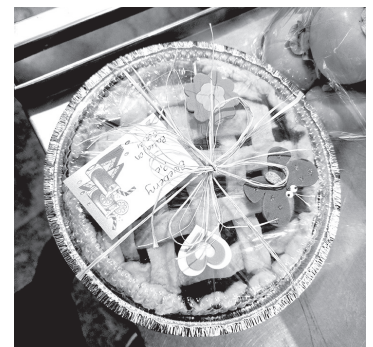

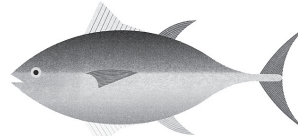

### NVC Hall and the Seattle City Council

The clean-up of the park next to NVC Hall by the city with 4x per week cleaning has had a significant effect on the park appearance and the change in the neighborhood. Let's hope the work continues.

### National Archives and Records Administration

U.S. Archivist Colleen Shogan, who leads the NARA which oversees government documents, photos and records, has instructed employees to erase references to Japanese American incarceration from education materials, and ordered the removal of Dorothea Lange's photos of WRA incarceration camps from a planned exhibit at the National Archives Museum. JA history is not the only one being targeted for this whitewashing. As our mission includes the "historical preservation and sharing of the legacy of the Japanese American

soldiers of World War II" we need to be ever vigilant on those who would work to erase the "ugly" parts of American history to have them happen all over again to others.

### Tom Kometani

I volunteered to say a few words of remembrance at Tom's service this past month and embarrassed myself and the NVC by missing the date. It was on my mind and on my calendar. ## NVC Statement on a False Historical Narrative

The NVC Executive Council is aware of some influential voices promising to invoke the Alien Enemies Act of 1798 – the same legislation used to justify the incarceration of Japanese American citizens without legal due process during WWII. These same people are also drawing misleading parallels between Americans serving prison terms after being found guilty of well-documented crimes by juries of their peers, and Japanese American families forced into mass detention camps without being charged with any crimes.

The NVC unequivocally refutes and condemns this false historical narrative in its entirety.

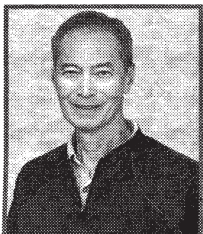
The distinction that makes these comparisons false and absurd is that the imprisoned Japanese American citizens were not charged with breaking any laws or committing any crimes before being forcibly removed from their homes and imprisoned.

Many Japanese American men of military age volunteered to enlist and fight in the United States Army at the start of WWII. Many volunteered even after being incarcerated. Drawing comparisons between the incarceration of Japanese American citizens and Americans serving prison sentences who were charged with specific crimes, provided access to legal counsel and due process, appeared in open court to be judged by fellow citizens, and found guilty of crimes including property theft, weapons-charges, assaulting, resisting or impeding law enforcement personnel, disrupting Congress, and seditious conspiracy against the United States of America, is misleading. The conduct on January 6, 2020, resulted in 140 police officers injured, one death, and several indirect deaths.

The Nisei Veterans Committee (NVC) was founded in 1946 by Japanese American military veterans who served in the 100th Infantry Battalion, 442nd Regimental Combat Team (the most decorated unit for its size and length of service in the history of the US military), the Military Intelligence Service (credited with saving countless Allied lives and shortening the war in the Pacific by two years), and other non-segregated units (e.g., 101st Airborne Division and 82nd Airborne Division). NVC membership includes military veterans from WWII, Korea, Vietnam, Desert Shield/Storm, the Global War on Terror (GWOT), and their communities.

NVC is committed to protect the American way of life as set forth by the Constitution of the United States and to preserve, perpetuate, and share the historical legacy of the Japanese American soldiers of WWII.

# JAVA & NJAMF Honor Veterans Day & Norio Uyematsu

JAVA and the National Japanese American Memorial Foundation (NJAMF) held its annual Veterans Day Program on Saturday, November 11th, at the National Japanese American Memorial in Washington, D.C. U.S. Army Corporal Norio Uyematsu was the keynote speaker for the Veterans Day Program.

Norio Uyematsu is a 93-year-old Korean War veteran from Anaheim, California, who has made it his mission to promote the story of the Japanese American Korean War veterans who served from June 25, 1950, to July 27, 1953.

After his wife Hanako Rose Fujikawa Uyematsu passed away in 2020, he did not know what to do with his life and lost focus on his reason for living. He needed to find a sense of purpose and was asked to write a list of things that he wanted to accomplish before he died. One was to preserve the legacy of the Japanese American Korean War veterans who served and were killed in action, and the other was to honor a man who gave his family a second chance at having a normal life in Brigham City, Utah, after they were told they needed to leave their Japanese American concentration camp, in Heart Mountain, Wyoming.

In 2022, he began his journey and attended the Wall of Remembrance Dedication at the Korean War Veterans Memorial in Washington, DC, on July 27, 2022. He had just received his Republic of Korea Ambassador for Peace Medal from the Los Angeles Korean Consulate prior

to his departure so he could wear it for the dedication. He was surprised to find that he was the only Japanese American Korean War veteran in attendance. Jessica Xiao, a contributor for AsAm News, found him as he was going back to the bus and interviewed him for a story at the age of 91. The Pacific Citizen newspaper also published a cover story about his visit as well.

He was invited to speak at the Brigham City Kiwanis Club meeting in November of 2022 for their Veterans Day observance, where he was able to fulfill his second wish about honoring Earl Garret Anderson, an LDS farmer in Brigham City, Utah, who gave his family and other Japanese families a place to live and work on his farm after they were released from camp in 1945. His generosity allowed the Uyematsu family to have a second chance at a normal life, and Norio enlisted in January 1949 at the age of 17 into the U.S. Army. The morning of his address, the Brigham City hometown newspaper, the Box Elder News Journal, had his story on the front page of the paper and made the Uyematsu's the talk of the town.

The following day, Norio and Patti Hirahara had a meeting with the Brigham City Museum. Museum Director Alana Blumenthal had heard Norio's address the day before, and she was ready for the question that needed to be asked. Would the museum consider holding an exhibition on the Japanese pioneers of Box Elder County in the future? The museum immediately

agreed, and his dream continued to flourish.

Congressman Lou Correa (CA-46) heard about Uyematsu and honored his Korean War story on the Congressional Record in November 2022 for Veteran's Day.

Norio (Nori) Uyematsu was Honorably Discharged from the U.S. Army in 1952 at the rank of Corporal, and his unit, the 521st Military Intelligence Service Platoon, was awarded the Meritorious Unit Commendation in November of 1952, where he interrogated prisoners of war.

Once he went into civilian life, he still wanted to promote veteran causes, and he joined the Kazuo Masuda Memorial VFW Post 3670, where he was a three-time post commander and is now the oldest member of the post. He was also a charter member of the Japanese American Korean War Association and a vice president. He is also a member of JAVA, the Korean War Veterans Association, and the American Legion.

He was honored at the 73rd Annual Nisei Week Japanese Festival in Little Tokyo as a Nisei

Week pioneer in 2013, and he rode in this year's Nisei Week parade as part of the military salute as a Korean War veteran.

Last year, he wanted to return to where he served during the Korean War since he was going to visit Japan. Congressman Lou Correa's office sought an opportunity for Norio Uyematsu to visit Misawa Air Base in Aomori Prefecture. Misawa Air Base responded, and Norio would be given a VIP Tour of the base on September 26, 2023. This was his first trip back to Misawa in 73 years since his Army unit was assigned to guard the base in 1950.

Once Misawa Public Affairs met Norio Uyematsu, they highlighted his story as their Veterans Day feature in 2023. The story was picked up by many online publications under the headline "Norio's Story: A Japanese American Korean War Veteran." His story was on the cover of the Pacific Citizen and on the front page of the Rafu Shimpo as well as being featured in the "Graybeards Magazine" of the Korean War Veterans Association.

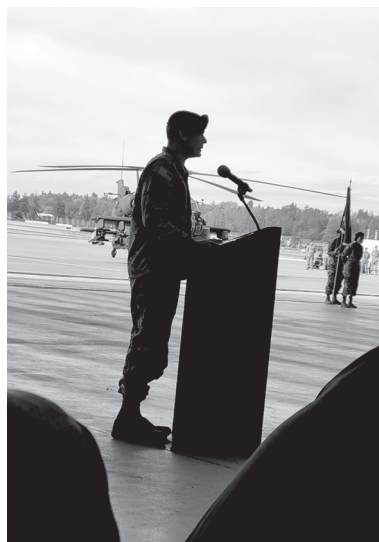

# First Corps Change of Command at Joint Base Lewis McChord

On October 25, 2024, Joint Base Lewis-McChord (JBLM) was the site of a significant military tradition—the Change of Command Ceremony for America’s First Corps. This event marked the transition of leadership from Lt. Gen. Xavier T. Brunson to Lt. Gen. Matthew W. McFarlane. NVC Past Commanders Michael Yaguchi and Allen Nakamoto and current NVC Commander Dale Watanabe attended the ceremony representing the Nisei Veterans Committee.

Lt. Gen. Brunson, who had commanded America’s First Corps since October 14, 2021, was celebrated for his exemplary leadership and strategic vision. During his tenure, he enhanced the readiness of the Corps and strengthened JBLM’s role as a power projection platform for the Indo-Pacific region. His efforts in championing the Army’s modernization initiatives, particularly in multi-domain operations and joint force integration, were highly praised. Brunson’s leadership was marked by a strong commitment

ment to the welfare of soldiers and their families, as well as the development of leaders at all levels. His next assignment will be as the commander of U.S. Forces Korea.

Lt. Gen. Brunson began his relationship with NVC during his command of 7th Infantry Division before transitioning to command America’s First Corp. He asked NVC to continue the relationship with First Corps and 7th ID through the new commander.

The ceremony was attended by soldiers of America’s First Corps, family members, distinguished guests, and friends. The divisional colors were assembled in formation beside major subordinate commands and JBLM tenant units. Gen. Charles A. Flynn, Commander of the United States Army-Pacific, presided over the ceremony as the reviewing officer.

In his outgoing speech, Lt. Gen. Brunson expressed his gratitude to those he served alongside, his

family and friends, and God. He encouraged everyone to maintain the connections and relationships built within and around the Corps, to embody the Army values, and to treat each other with dignity and respect.

Lt. Gen. McFarlane, the new commander, addressed the audience with enthusiasm, expressing his eagerness to

lead the soldiers of America's First Corps. He wished Lt. Gen. Brunson success in his new role in South Korea.

Lt. Gen. McFarlane echoed his predecessor's sentiment and commitment to the NVC contingent at the reception after the ceremony. He had visited the NVC as First Corp's Deputy Commander earlier this year as



part of the Japan-U.S. Military Program (JUMP) event organized by the Japan-America Society of the State of Washington partnering with the NVC.

The Change of Command Ceremony is a time-honored military tradition that symbolizes the transfer of responsibility, authority, and accountability from one leader to another. It reinforces the continuity of leadership and the values that the Corps upholds.
